# Barbara Anne McKinnon: Panel 39 - 1999, 2000, 2001

- How long have you been a member? If all goes well, my 29th Al-Anon birthday will be in July

  How were you introduced to Al-Anon? Our son was in treatment at Lancaster Recovery Center and I suppose after the counselors heard his story they truly decided that his mother needed Al-Anon in
- the worst way. Two counselors called me and at that point I would have done anything I went, fussing to myself that it was not I who had the problem (I was dealing with a prescription drug ad-
- dicted mother, an alcoholic spouse, and an alcoholic son—comes in groups in some families!).

  When I left the meeting that first night I knew I had found just what I needed.

Were there special challenges in service? To be very honest with everyone, speaking and leading groups in public have never been any trouble for me. I really enjoyed being Chairman, even though there were problems along the way, it, to me, was rewarding. In high school my English teacher spent most of her time teaching and practicing public speaking – one of my appreciations in this program is recognizing that I had an opportunity to say a big thank you to her before she died.

Is there something about Al-Anon you would change? The biggest change I would make would be to go back to the day when COMMITMENT really meant something. I can remember being told to go to a meeting no matter if you were tired, or didn't want to go, it would be to my advantage. Then I was told to get into service. It appears that so many today do not feel the commitment to meetings nor service. And they are missing so much.

What is your personal meaning of Al-Anon? *Meaning of Al-Anon: I went to Al-Anon because at that point I had reached the end of my rope. I stayed because I felt comfortable and was showed a spiritual program to work to help me get better. Al-Anon means more to me than recovery from living with active alcoholism, it means a whole new family for me, a family with whom I sometimes disagree with but most of the time welcome as my friends/family. It means I began recovering from fear of taking risks, learning to go places for my enjoyment. There are many times when I still feel like a newcomer as I listen to others sharing their experience, strength, and hope.* 

## **DELEGATE for South Carolina Area 50**

I want first, to thank everyone for their love and support, the many cards and the love gifts sent to me as WSC. I also want to take this time to say how very proud I am of the SC Area as a whole. When listening to other delegates at the WSC and some of the issues they face in their areas, I have to say that we are a very healthy area. I would like to take this opportunity to thank all the past delegates for their excellent leadership and stewardship that has brought us here and kept us healthy.

Participating in the World Service Conference was everything I had hoped it would be and more. I had received a lot of experience, strength and hope from past delegates before I went to conference. That gave me a head start on what to expect at conference. It also helped that I had met most of the Southeast Delegates at the Regional delegates Conference in February. The tone of the Conference and watching it in action was inspiring. You could really see that everyone wanted us to succeed and that presuming good will was not just a catch-phrase. I have a number of things to tell you from Conference:

We voted on the property decision and it was passed to continue to own the WSO property. We were there at the open house on Saturday and witnessed the burning of the mortgage.

The Al-Anon website has been updated. It is much more user friendly. It gives you quick access to audio, video and text information. It debuted April 13. Hopefully, some of you have seen it. If not, please take the time to check it out. I know you will like it. The new green and blue icon identifies the new series of podcasts. They cover many topics and allow for comments. Also under blogs are several subjects. There is a need for Spanish and/or French members to share. You will also find the Unlimited Abundant Skills Inventory on the website. I encourage all of you to fill this out.

Our new book, <u>Many Voices</u>, <u>One Journey</u> is also now out. It is 400+ pages of history and recovery.

Financially, WSO is in good health. Contributions and sales have stayed relatively consistent even in this economy. The audit will be posted on the members' website. WSO still needs our contributions to continue with a prudent reserve. Contributions are also need to expand our circle of hope. Our contributions support PSA's, literature, Conference, etc.

E-communities, which several of our coordinators have access to, are also expanding. Past and present conference members will have access around the 1<sup>st</sup> of May. Area Chairs should have access in August, with DR's getting access sometime in the fall. This will enable discussions with our counterparts in other areas.

There is a new Al-Anon DVD video coming out. I have a copy for anyone that would like to view it. There are new TV and Radio PSA's available. Al-Anon has the top 2% of all PSA's per the latest Neilson Report. Send emails to any Radio or Television station that you hear playing our PSA's to thank them. Public Outreach Coordinators are asked to develop and maintain a distribution list of members excited to assist in outreach efforts. Cut and paste you e-community comments and send them to your list. You can also make drastic improvements to Al-Anon Faces Alcoholism use using a distribution list. If you are interested, please give your email address to

Nancy G., our Public Outreach coordinator.

Area Highlights will no longer be printed after the summer issue. It will be available on the members' website.

We are staying about the same in *Forum* subscriptions. It averages nationally about 1.5 - 2.5 subscriptions per group. These are a great tool for meetings. It gives people contemporary sharings that can assist them. It is also a great resource for articles for parent of Alcoholics.

One of the questions that came up at conference was can we be of better service working with professionals or treatment centers? Can we be more welcoming to newcomers? We have lost our foundation of referrals. Haven't revised guidelines/suggestions to match treatment programs – they have changed, become more condensed programs. Some suggestions are having more speaker meetings; having a precontact greet someone at the door; rebuild our foundations thru treatment centers or substance abuse counselors.

One of the most exciting pieces of news is the new soft-cover *How Al-Anon Works*. This version costs \$5 and encourages groups to buy these to give every new member of the fellowship a copy. For years, AA has had the practice of giving new members a copy of their Big Book. Now, Al-Anon has a tool to do much the same thing with their new members. These soft-cover versions are meant to be an outreach tool to new members, not take the place of the hard-cover book that ongoing members purchase. We talked a lot at conference about Unlimited Abundant Resources – where we can use our money by paying it forward to new members with this book. *How Al-Anon Works* is mentioned in the latest edition of *O Magazine* in an interview with Ashley Judd. It was one of her ten most influential books list. In coordination with Oprah, there will be an App for I-Phones that will allow you to hear a sample chapter of *How Al-Anon Works*.

While at Conference I participated in a Thought Force on using the *Service Manual*. We will be continuing to work on this thru the summer and may present our information at the next conference. I also saw presentations from Thought Forces on Dual Membership; Do Not Refer policies, Memorial Contributions, How Service Promotes Growth and Conference Structure. We also saw presentations on TEAM events and voted on the budget, audit and Trustees report. We elected a new Chairman of the Board of Trustees and other positions. We saw a Task Force Presentation on submitting items for the Conference Agenda as well.

We had a presentation on Cultural Diversity. We are still predominantly 56 year old white women in Al-Anon and need to develop new strategies to reach out to other cultures and ethnicities.

To those of you who have been asking me about the possibility of getting CAL on e-readers, etc., we have been told that WSO is looking into this possibility. One of the issues is that Amazon wants 60% of the profit to do it through them, so WSO is looking at other ways to accomplish this.

We were presented with information about the International Convention in Vancouver in 2013. More information about International should be available in Fall 2012.

The site for the 2012 World Service Conference was announced. It will be in Stamford, CT and we will all be visiting Stepping Stones.

I have many pieces of information available on most of these topics. If you would like more detailed information on any of these, please let me know. I would be happy to discuss a presentation to your district focusing on any of these topics.

Big news!!! New multi – purpose Public Outreach video on DVD. It has three primary audiences: Adults who might be affected by someone else's drinking, Teens who might be affected by someone else's drinking and Professionals who might be in a position to refer patients, clients, customers and students to Al-Anon and Alateen meetings. Decide who you think would best benefit from this – school, colleges, guidance counselors, police, clergy – it is \$5.00.

Remind the membership to take the WSO survey, it is easy and quick and check out the new WSO website, as well as the state website...

Districts are having Public Outreach "pushes". They are sending out Letters to the Professionals, Clergy and Police, going to Health Fairs around their cities and towns to promote Al-Anon and Alateen. # Submitted By Gayle our District 2 Representative

The South Carolina School for the Deaf and Blind in Spartanburg recently contacted AA with a request that several members visit the school and address the students, introducing them to AA and offering resources to help any who struggle with alcohol. AA contacted Al-Anon, and on the Monday following our annual Al-Anon/Alateen Convention, three AA's and two Al-Anons met with about 75 students and several staff members at the school and presented a message of hope and healing. The presentation on that Monday was primarily focused on AA. One blind AA member told his story; and a short, animated film was shown depicting the dangers of alcoholism and the healing offered through AA. Meeting formats were briefly described, and then students were invited to ask questions. I and another Al-Anon member answered questions about Al-Anon, and briefly explained why we needed to practice the 12 steps ourselves--that we needed to recover from the effects of the disease

of alcoholism just like the alcoholics did. I emphasized that both groups viewed each other with great compassion, and that we strove to cooperate as we each worked to recover from the effects of a deadly disease. The AA's were able to leave with the students and staff literature to help them better understand the disease of alcoholism and the path of recovery offered through AA's 12 steps. Some of these materials were printed in Braille.

In the days and weeks following the presentation, the school counselors received visits from a number of students wanting to discuss issues related to alcohol abuse. Some of the students talked about the use of alcohol in their homes. The School would like to host a presentation again in the fall, this time centered upon Al-Anon and Alateen. In preparation, I and other local Al-Anon members are seeking resources that will help carry the message. If any reader knows of a deaf or a bind Al-Anon member who can clear a SLED background check and who would be willing to come to Spartanburg to present their story to the students in the fall, please contact me, as their contribution would be greatly appreciated. If anyone knows of a source of CAL printed in Braille, this, too would add significantly to the value of a presentation at the school. Finally, if an Alateen member would be willing to stand and tell his or her story to the students, it would help them

identify with the message of hope that Al-Anon and Alateen have to offer. Additionally, any monetary contributions to help with the purchase of literature will help further carry the message.

"When anyone, anywhere reaches out for help..." Let's together offer a hand to those within the deaf and blind community who suffer from our shared disease, and who do not have available to them the same precious resources that we in Al-Anon and Alateen enjoy so freely.

# AREA ALATEEN COORDINATOR REPORT —- AWSC May 7, 2011

As we move into the 2<sup>nd</sup> quarter of our first term, I am happy to report that our SC Alateen program is making progress (not perfection) in our four primary concerns. We are hopeful that we will entrust more support from the membership at large and that you will spread the word.

<u>Transition of Alateen Area Coordinators:</u> A successful transfer of the Alateen bank account occurred from SunTrust to Wachovia. Pertinent information has been shared with key Area Officers and transactions will be documented (in an Excel spreadsheet format) for future reporting purposes. Between Susan O and I, we have participated in three WSO Conference calls. Highlights follow:

WSO has introduced an online discussion board via e-communities where all Area Alateen Coordinators can communicate directly with each other. The current three topics: Structure of Area Alateen Conferences, Alateen Sponsor Certification Requirements & Alateen Public Outreach.

An Alateen Service E-Manual is forthcoming to the WSO (members only) website. A variety of Alateen Service resources will be available for download. We were asked for suggestions of information we would like to access there. Response ranged from successful meeting topics to request for translations.

Alateen Chat Room Meetings are just getting off the ground. A relatively recent phenomenon, the Alateen Chat meeting rooms are screened for high security. Currently 11 areas have applied and been approved and only 6 scheduled. We are one of the 11 and are collecting names and e-mail addresses of (teens and sponsors) interested in participating. We are planning a 'hands on' Chat meeting workshop at our upcoming 2011 SC Alateen Conference.

<u>Providing more support to Alateen Sponsors:</u> We are grateful to our Webmaster who has jumped through hoops with us to provide our sponsors the necessary documents and resources for download. Since January, these include business meeting notes and a range of forms needed necessary for transporting teens, updating group & sponsor records including certification and recertification forms.

More Alateen Sponsor help and support is needed – especially in districts 1, 2, 8 where there currently are no Alateen meetings open to the public. Also, Districts 5 & 9 are running on minimum (2) to no Alateen Sponsor back up for weekly Alateen meetings. There are many ways members can work their program supporting their district Alateens and sponsors that would not require weekly attendance at an Alateen group. Ask an Alateen sponsor or let me hear from you at sc\_alateen@yahoo.com.

Increasing communications among teens and sponsors within the area:

The first Alateen E-News was released 2/13/2011 to an approximate 60 members (teens & sponsors) within the Alateen fellowship with two more released since. Among the reasons this electronic news was created was to serve as a communication vehicle to alert our area wide fellowship of new postings to the website, call for input on upcoming Alateen events and activities in the planning stages, & to share member and group news. The second E-News drew several responses (from adults) that provided a learning opportunity that resulted in the creation of our official "Rules and FAQ's" (...i.e. internet etiquette) on our new electronic communications. This guide defines what is okay and not okay when responding to mail from our new e-mail and has been posted to the website. Check it out.

Our new e-mail address - sc alateen@yahoo.com - was established as command central for Area Alateen to receive inquiries from the public as well as to disperse communications throughout the fellowship. This mail comes directly to me. It is the address from which the Alateen E-News originates. Please add this to your own address book (for referral purposes) so that you will be able to receive mail – instead of going to your spam box. Since we have gone live (late January 2011) 30+ inquiries have been received from the public, responded to with forwarding contact information provided to appropriate DRs and Alateen contacts. All but District 1 thus far have been sent referrals. When you receive these referrals, please let me know if you are NOT the correct contact and/or if you are unable to follow up.

A Request for more Public Outreach – There has been some passionate discussions taking place about how to spread the word about Alateen meetings and the need for more sponsor support. The topic often comes around to a decision to not post Alateen meetings to the public made at the area level in the early forming of SC Alateen and prior to the internet becoming the central communication channel it is today.

## Increase Alateen/Alateen Sponsor participation and voice at all levels (District/Area /Conferences &

<u>Conventions</u>): At Area Assembly we held our first "Alateen Break-out Session" where we began planning our 2011 SC Alateen Conference. We also tossed around various ways to improve communications among our fellowship and invited our Webmaster to help us explore various methods of using the website. Since January, we have posted many new resources accessible via the *members only* pages at the website, then clicking on *Area 50 Alateen* tab. Check us out!

At the 2011 SC Al-Anon/Alateen Convention in Myrtle Beach several activities were added to the weekend to enrich the Alateen experience. Among these included a Friday Night business meeting, a midnight hot seat meeting and the favorite Saturday afternoon beach/poolside downtime with Frisbee.

**2011 SC Alateen Camp /July** 15 – 17. The Contract for services at Camp Kinard was secured in early February. An increase of fees has occurred for the weekend and will be reflected in a slight increase from \$85 per member to \$90. We are requesting a pre- registration (form available online) and a \$15 deposit. The remaining \$75 balance can be paid at arrival. A limited number of scholarships are available by request. Al-Anon fellowship can make donations (checks written to SC ALATEEN) and mailed to: AC Sponsor/1102 Laudonniere St, / Bft, SC 29902.

State Alateen Rep Gene W is working hard to pub together the Alateen program in cooperation with all groups. He will provide a separate report on the status of plans.

District 6 is the first to consider a teen service position be added to their slate of officers and coordinators. The proposal under review includes a description of duties and term for the teen District Alateen Coordinator position. This new voice would serve as direct link from GR to State Alateen Rep and serve in partnership with the adult District Alateen Coordinator.
