**District 4 Report**: Margaret gave the report for Carrie. They will host their first All Day on September 14, 2008 with activities starting at 3:00 at Virginia Wingard United Methodist Church. Their Holiday Dinner will be held December 13, 2008 at Ashland United Methodist Church. Their next district meeting will be held the second Sunday in July. Members visit Morris Village once a month talking and educating patients about Al-Anon Family Groups.

**District 5:** Marianne invited everyone to come to Florence where they have Al-Anon meetings every day except Friday and Sunday. Manning is working on getting an Al-Anon meeting.

**District 6:** Jan H. - The following activities have resulted from these interests.

1) While each group is provided a copy of the new Service manual from WSO for shared membership use, the Dist voted on purchasing and providing a personal copy of the New Service Manual to all new GR's as a way of introducing and welcoming officers to their new level of service. The distribution of those copies have been accomplished

2) Two workshops on Attraction vs Promotion have been held by district officers. In January, Alt DR John C presented & in March, secretary, Julie H, presented. A short-range project was introduced in March – for all GR's to go back to their home groups and ask members to take a meeting list to their neighborhood grocery store and report back. A long-range project is now in the information gathering stage with plans to distribute Alateen literature to Middle & High School Guidance Counselors, Nurses & Psychologists. GR's with Alateen groups – or GR's interested in starting a group, have been asked to go back to their home groups to determine contacts and how many packets would be needed to distribute in their communities - & to report back at our July meeting. Literature orders will be made in time for preparing the packets for distribution at the Sept meeting. Among the possible items discussed for inclusion were the letter to professionals, Al-Anon faces Alcoholism 200X and an Alateen sponsor contact.

3) DR visits to area meetings were discussed as another way to touch base with groups, invite participation at district and help identify group needs. Among the groups visited: ABC, AFG a Service Information Group in Bluffton – a small but active membership supporting Al-Anon & Alateen groups throughout Beaufort County - which includes Beaufort, Bluffton & Hilton Head . Meeting bi-monthly at the Atlanta Bread Co (Yum!) They are provide meeting lists, purchase & distribute literature, attend health fairs and maintain the area telephone hotline. They are researching ways to lower expenses – especially telephone expense, possibly with a cell phone.

Ultimate Alateen AFG meets in Bluffton with sponsors Bob C and Brandon W. They just celebrated their 4<sup>th</sup> year anniversary – with pizza. A vital & growing group of 10-16 meet Tuesday evenings at the Bluffton United Methodist Church; They could use more Alateen support with added sponsors.

Hilton Head AFG with GR Mary Kay T, meets on Thursday night at St. Lukes Episcopal – located at the south end of the island (close to the beach), is a small group with sporatic regular attendees but a steady stream of visitors passing through while on vacation. Current GR is unable to attend district meetings and could use additional officers to share this responsibility.

4) A Drawing for literature at district meetings has been added.

Announcements: Plans for an Alateen Sponsorship Training for Dist 6 is in the works coordinated by Dist 6 Alateen Coordinator, Sally M. A meeting place has been acquired at the Al-Anon meeting room in Alano Hall in Port Royal/Beaufort, Wed, June 4, 6:30-8pm

Our State Alateen Rep Kasey H (Home group Easy Does It Alateen in Beaufort) spoke at the SC / AA convention in Greenville this past April in addition to her debut speaking at the SC Al-Anon Alateen Convention at Myrtle Beach! She is also currently making plans for the upcoming Alateen Camp Aug 1-3 "Change your Fate in 2008" under the guidance of area Alateen Coordinator. All Alateens and sponsors are encouraged to pass along ideas & contributions for workshops and special events to Kasey as soon as possible.

We have ordered 400 Al-Anon Faces Alcoholism to distribute and we have had a Public Outreach Fundraiser. I'm proud to say we earned \$556.00. I am also talking with two (2) companies about billboards, but nothing has come together

on that yet, so will get back with you on it. We have our all day planned for October 18<sup>th</sup> and invited everyone. Flyers are available today.

**District 9 Report**: Vicki – District 9 will have their All Day on Saturday, September 20<sup>th</sup> at Asbury Hills. Flyers are available to take to your groups today.

**District 10 Report**: Marie for MaryAnn – They are working on getting literature to youth treatment centers

**<u>Reflector Editor Report</u>** - Jan R. Well, the first issue with me as editor has been printed and mailed. After some initial trials, it really wasn't that bad getting it formatted and in newsletter form. I've learned a lot putting it together and look forward to the next issue in September.

I have, however, several concerns regarding printing and mailing costs. We currently have approximately 35 subscribers to the Reflector ( $3 \times 35 = 105$ /four issues a year). It cost over  $2 \times 2$  per copy to print and mail the Reflector. Not only are we operating at a loss, but we are basically providing 3 issues a year for nothing.

This issue I had 260 copies printed (\$370 plus tax) and mailed 255 copies at \$0.59 postage each. (\$150.45) I also emailed Publisher versions to most people that I had email address for. I have since learned how to save a copy in PDF format and can email anyone a copy that way.

I checked with the Post Office about getting a non-profit mailing permit number. It requires a \$180 application fee and another \$180 in additional fees. We also have to fill out the application and submit copies of the Reflector to show that we are a non-profit organization. Since several other areas have non-profit permits for their newsletters, I would think it would be easy to get Okayed for it. With a non-profit permit number, mailing the newsletters would cost about \$0.16 apiece for 200+ newsletters. Another possibility would be doing a bulk mail. I'm not sure of the exact postage since the last increase, but it would be less than the current \$0.59 we pay. I've had some experience in doing bulk mail, so would just need refreshing on the process and the necessary supplies.

As a result, I have several recommendations for cutting costs:

1) Email copies of the Reflector to everyone who has email access and not snail mail them. They can then print as many copies as they want.

2) Only have subscriptions for those people who don't have computer access or who are willing to pay an increased cost for The Reflector. (Some areas charge anywhere from \$6 to \$12 per year)

3) Have subscription renewals during January only to be able to keep up with dates, etc.

4) No longer supply free/complimentary copies to any group, area trusted servant, etc. The only complimentary copies would go to WSO and other area newsletter editors, literature distribution centers, etc.

5) Cut down on the number of issues the Reflector goes out each year.

While these are only suggestions, we need to take a hard look at the costs and the benefits. Any or all of my recommendations would help in the overall cost of putting out each issue.

When you add the costs of my preparing the newsletter (paper, ink, labels, tabs, cd's) it makes the cost per copy go up. As the cost of everything else continues to rise, I am concerned that these costs will only go up as well.

I hope everyone enjoyed my first issue. Please let me know what you liked and didn't like, what I might have left out or missed, or anyone that should have gotten an issue and didn't. I will endeavor to improve as I go along. Yours in service, Jan Rogerson, Editor - The Reflector

The development of the "Members Only" side of the web site occurs when other members (not me) have documents/information/presentations/ideas for sharing. I take their info and upload to the web. Here come opportunities for you to contribute.

# 2008 Convention Final Report to Convention 2009 Dale C.

Our closing meeting brought about many interesting opinions. Below are listed some general things we thought important to mention.

- 1. There needs to be a note on the registration form letting Alateen know their meetings don't begin until Friday evening.
- 2. Encourage folks to keep seated during speaker meeting.
- 3. It would be good to have one room available for open meetings anytime.
- 4. It would be good to have a room in Live Oaks to meet and talk. The lobby area was often really crowded.
- 5. The Hospitality Room was a sore point for a lot of people. Perhaps an announcement could be made at beginning of convention as to why it is in another building. It does give a place for people in other building to meet. It is nice to get outside and stretch legs to walk over to it. It is a problem for those who don't walk well.
- 6. If Springmaid makes a golf cart available for non-walkers, announce procedure for getting it.
- 7. More raffles would be better for those with limited funds. Gift cards should be raffle items.
- 8. 113 people did not pre-register. Perhaps offer incentive for pre-register. Should plan to make at least 275 -300 registration packets in all.
- 9. Pre-ordering T-shirts was great. We sold 83 in all.
- 10. Alateens had too much freedom. More should be planned for them and they should be accompanied by an adult at all times. Alateen rep should be informed of arrival and departure.
- 11. Book covers were requested frequently. This would be a good idea for the country store.
- 12. Sunday morning workshop planned for 30. 50 were in attendance.
- 13. Rooms for workshops are large. Chairs should be arranged for closeness in order to hear better and build rapport among group.
- Goody bags for speakers should include bottled water. John Holmes would like to receive a schedule of activities as soon as it is confirmed. His info: John Holmes 118 Holmes Dr. Batesburg, SC 29006
- 15. Put Registration tables somewhere besides right across from the doors to the speaker room.

- 16. Be sure hostess know and keep up with ending times.
- 17. Confirm do AA members pay for registration if they are only there to help with the AA meeting?
- 18. Water station is free please make available in speaker room lobby. Coffee was greatly appreciated. Since this is not a money-making function, please consider providing it at least in the mornings.
- 19. Alateens need adult accompaniment anytime anywhere they go.
- 20. Having the first floor room for workshops was great.
- 21. Perhaps there should be more planned for alateen.
- 22. Close registration table during speakers and workshops.

Individual chair persons were asked what they wished they had known before starting their work. The following comments were made:

- 1. Had I known from the outset that everyone would be so supportive, taking me under their wing and helping me, I wouldn't have been so nervous about joining the planning committee.
- 2. I wish I had known the hospitality building would be in a separate building from the meetings. I don't know the answer to this, but I hope the next committee can get more people over there, especially for breakfast. We had a lot of stuff left over and I think it's because of the location.
- 3. It was harder to find people to do workshops being the furthest distance from the convention. Not sure who could get off work, pay for room, etc.
- 4. Getting volunteers to help in the fundraising room and hospitality room would be so difficult.
- 5. The State AA chairman should be asked to chair the AA meeting at the convention. No reimbursement is given to him. If he doesn't come then can ask anyone.

Individual chair persons were also asked what they learned that might help the next committee. These are the comments that were made:

- 1. Always keep 2 people at the ticket table. Start off with beginning bids for baskets to up the amount. On Saturday night, have in advance 2 people in place to count quilt tickets shortly after raffle is over. Caution participants to write legibly.
- 2. Let go and let God.
- 3. This was an extremely rewarding and growing experience!
- 4. 30 minutes between workshop and speaker meeting is better than 15 minutes.
- 5. Have signs up as to where to go in advance of anyone arriving.
- 6. Let those who will be coming for the first time know where to register at Springmaid vs. where to register for the convention.
- 7. Have coffee and water out on the table outside the speaker room. It is expensive but this is not a money making venture so we can splurge a little.
- 8. Get an early start lining up volunteers for the hospitality room.

Considering the amount we cleared (about \$1500 above seed money) I think it was money well spent.
