Members are encouraged to submit suggestions of what they consider the best of *Forum* articles, especially from the last few years

"CAL Corner" Topics: This department is featured each month in *The Forum* magazine. It contains members' sharings on how a particular piece of our literature has enhanced their recovery. Please urge members to write about Intimacy in *Alcoholic Relationships* (B-33), *As We Understood...* (B-11), the *Just for Today* (M-12) and *Just for Tonight* (M-81) Bookmarks, and *Blueprint for Progress* (P-5 and P-91). Please see the writing guideline for "CAL Corner" in the Guidelines & Procedures folder under the "Library" folders in the Literature Coordinator community. --Some of us have can trace our recovery by remembering where we were when we first read some of these books, and perhaps we remember how we received them then and how we read them now!

Intimacy in Alcoholic Relationships (B-33) is now a year old. As sometimes happens with new books in their second year, sales are starting to slow down. Please encourage members and groups to continue to use and support this wonderful book!

Conference Approved Literature is a vital part of our program's life's blood! It allows us to keep our message both consistent and adaptive! We as a fellowship have done a wonderful job supporting it, so let's keep that flame burning bright!

It is anticipated that this will occur within the next 30 days. The Area 50 Alateen program looks forward to being in compliance with Area 50 guidelines and motions, as well as IRS 501(c)(4) requirements. It is our hope that these actions will bring unity and harmony, as well as accuracy, efficiency, and transparency. We also hope that these decisions will foster a presumption of goodwill and an atmosphere of trust that the good people in this fellowship will make excellent informed decisions under this new unified financial structure.

Alateen Conference 2019

The 43rd annual Alateen Conference (aka, Camp) was held August 23-25 at Camp Kinard in Batesburg-Leesville. The theme was "Keep an Open Mind". We all had a wonderful time celebrating 62 years of Alateen, with open discussion meetings, speaker meetings (including several Alateens who shared their story for the first time and a few Alateen Sponsors), workshops, an ice cream party, a night hike/trust walk, and of course, lots of time in the swimming pool. We created a Conference banner and made Thank You cards for those who provided donations.

Marissa M. (Alateen State Representative) and Mike J. (Alternate State Representative) spent countless hours brainstorming, planning, coordinating, delegating, and leading this event, with Jennifer M. (Past Alternate State Representative) serving as the mentor in planning the Conference. As a result, the Alateens took ownership of their recovery through service, and there was just the right balance of activities/down time. The respect everyone showed each other created an atmosphere of emotional safety and serenity, which was challenging at times because the schedule was constantly changing due to weather.

South Carolina Alateen elections have resulted in Mike J. from Myrtle Beach being the new Alateen State Representative, and Melissa B. and Erica H. (both from Summerville) being the Co-Alternate Representatives. These wonderful Alateens will assume their service positions in January 2020. Many thanks to Marissa M, Mike J, and Caroline N. for all your hard work in your service positions in 2019. The Conference ended with a touching tribute to Jennifer M., who was attending her last Conference and has already begun transitioning to Al-Anon.

The theme for the 2020 Conference will be "Togetherness Foreverness".

2019 SCAC attendance figures were as follows:

- 39 total in attendance (10 more than in 2018, despite the fact that Conference occurred in August after school had already started)
- 27 attended the entire weekend - 16 Alateens and 11 AMIAS/Sponsors (2 more than in 2018)

- 12 Saturday only participants (6 AI-Anons, 1 AMIAS/Sponsor, and 5 Alateens) – (8 more than in 2018)
- 21 Alateens were able to experience Conference this year (5 more than in 2018)
- 6 Alateens attended their first Conference!
- 12 certified AMIAS were present to show their love and support (2 more than in 2018)
- Excellent ratio of certified AMIAS/Alateens for safety (requirement is one AMIAS for every 7 Alateens)
- 6 AI-/Anons supported the Conference on Saturday (3 more than in 2018).
- Please invite everyone in your groups to attend the next Alateen Conference, which will be held from August 21-23, 2020 at Camp Kinard again
- Participants came from 6 Alateen groups within 5 Districts (#4, 6,7,8, and 9)

Alateen Conference Finances

The cost per person for the entire weekend was \$110, and the cost for Saturday only attendance was \$15.

- Because of the generous contributions from individuals, groups, and districts, we are delighted to report that everyone who needed help paying for registration received it.
- Total cost for Camp Kinard, snacks, decorations, photocopies, and workshop supplies was \$4,164.52. Total incoming funds (donations and registration fees) was \$3,168. Thus expenses exceeded income by \$996.52. We had 3 cabins this year, which increased the cost, beyond projections. Therefore, all costs will be analyzed to determine the registration fees for the 2020 Alateen Conference.
- \$2,623 was received in donations from individuals, groups, and districts. \$2,605 of this was applied toward registrations. \$545 was collected in registration fees.

2020 AI-Anon/Alateen State Convention

As it currently stands, the 2020 Area Budget currently contains line items for the following Alateen expenses: travel expenses for the AAC, AAPP, and Alateen State Representative to attend Area level meetings, photocopies and postage, and a \$1,000 Advance for Alateen Conference at Camp Kinard. Therefore, if any individuals, groups, or districts would like to contribute toward snacks for Alateens at

the February 2020 AFG Convention, we ask that they give any donations directly to their District Alateen Coordinator or Alateen Group Sponsor.

We have already coordinated with the 2020 Convention Committee, and they would like to see the Alateens continue their “Best Seats in the House” drawing. It will be considered a Convention fundraiser, and the Convention Committee will have the final say regarding the use of any donations collected. Alateens will arrive 30 minutes prior to each Speaker meeting and will complete each drawing at least 5 minutes before the Speaker meeting begins.

As always, Alateens attending Convention will stay with either their parent/guardian or a certified AMIAS of the same gender. Because the parent/guardian/AMIAS are expected to pay for their own rooms, no Area, District, or Group funds have been or will be used for this purpose.

In closing, I would like to thank the Area for the opportunity to serve as the Area Alateen Coordinator
